## **4B. RESOLUTION 08/2025**

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE DOWNTOWN DEVELOPMENT AUTHORITY OF THE CITY OF MIAMI, FLORIDA ("MIAMI DDA"), BY A FOUR-FIFTHS (4/5THS) AFFIRMATIVE VOTE, AFTER AN ADVERTISED PUBLIC HEARING, AUTHORIZING THE CEO/EXECUTIVE DIRECTOR TO ACCEPT

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE DOWNTOWN DEVELOPMENT AUTHORITY OF THE CITY OF MIAMI, FLORIDA ("MIAMI DDA") AUTHORIZING THE CEO/EXECUTIVE DIRECTOR TO EXTEND THE PROFESSIONAL SERVICES AGREEMENT WITH MYDATT SERVICES, INC. D/B/A BLOCK BY BLOCK, AN OHIO FOREIGN PROFIT CORPORATION AUTHORIZED TO CONDUCT BUSINESS IN THE STATE OF FLORIDA, FOR THE CONTINUED PROVISION OF SAFETY AND HOSPITALITY RELATED SERVICES FOR DOWNTOWN MIAMI, ON A MONTH-TO-MONTH BASIS EFFECTIVE JULY 1, 2024 UNTIL THE AWARD OF A COMPETITIVE RFP PROCESS IS COMPLETED; FURTHER AUTHORIZING THE EXECUTIVE DIRECTOR TO EXECUTE ANY AND ALL DOCUMENTS IN A FORM ACCEPTABLE TO THE CITY ATTORNEY.

## **4D. RESOLUTION 10/2025**

A RESOLUTION OF THE MIAMI DOWNTOWN DEVELOPMENT AUTHORITY OF THE CITY OF MIAMI, FLORIDA ("MIAMI DDA"), BY A FOUR-FIFTHS VOTE, FINDING THAT COMPETITIVE NEGOTIATION METHODS AND PROCEDURES ARE NOT PRACTICABLE OR ADVANTAGEOUS TO THE MIAMI DDA PURSUANT TO SECTION 18-85(A) OF THE CODE OF THE CITY OF MIAMI, FLORIDA, AS AMENDED; WAIVING THE REQUIREMENTS FOR SAID PROCEDURES; AUTHORIZING THE ALLOCATION OF AN AMOUNT NOT TO EXCEED TWENTY-FIVE THOUSAND DOLLARS (\$25,000.00) AS ALLOCATED IN THE FISCAL YEAR 2024-2025 BUDGET TO THE 2025 DOWNTOWN DIGITAL COOPERATIVE ADVERTISING PROGRAM FOR PARTICIPATION IN ONE (1) DIGITAL COOPERATIVE ADVERTISING PROGRAMS WITH THE GREATER MIAMI CONVENTION AND VISITORS BUREAU AND DOWNTOWN MIAMI HOTELS; AUTHORIZING THE CHIEF EXECUTIVE OFFICER/EXECUTIVE DIRECTOR TO NEGOTIATE AND EXECUTE ANY AND ALL DOCUMENTS, IN A FORM ACCEPTABLE TO THE GENERAL COUNSEL. NECESSARY TO EFFECTUATE THE PROGRAM.
